THIS AGREEMENT is entered into between Gainey Cornerstone Arabians, herein called STALLION OWNER,
And _____, herein called MARE OWNER/LESSEE.

These parties agree as follows:

1. I, _____, hereby confirm my reservation to the Purebred Arabian Stallion, **HG Esquire+ Reg.# 579802** for the mare described below.
2. **FEES:** Fee(s) are \$1500 PB/\$1000 all others - payable as follows: \$250 Non-Refundable Booking Fee to be submitted with signed contract **STUD FEE:** ½ due prior to or at time of first collection, remainder of balance due not later than 30 days after insemination providing the mare has safely checked in foal.
3. **For Transported Semen** mare owner/lessee is responsible for collection and shipping cost per shipment for semen, which is shipped to their mare. This fee is for the collection, materials, semen preparation and shipping fees. It is necessary for a 24 hour notice for scheduling semen collection to avoid rush charges. "GCA" to provide all contact information for collecting of semen. If stallion has to be hauled to facility to be collected, an \$85 haul charge will occur.
4. It is understood it is mare owner's/lessee responsibility to have the mare examined by a licensed veterinarian periodically throughout the mares' pregnancy and to keep the stallion owner notified of her pregnancy status at that time.
5. This contract guarantees return privileges' for the same mare if the mare is examined by a licensed veterinarian and found to be barren. If the mare cannot conceive then the mare owner/lessee may substitute another mare. This contract is transferable with written permission between "GCA" and mare owner/lessee and is good for contract year signed and the next breeding year only.
6. Should the mare not produce a live foal (First 48 hours) that stands and nurses, the mare owner/lessee shall be entitled to a return breeding. If the foal dies for any reason, a statement of details by a licensed veterinarian must follow with-in 10 days of the foal's death. This clause is also binding in case of abortion. It will be necessary for mare owner/lessee to pay the additional collection/hauling fee's during the next breeding season.
7. It is understood that the mare owner/lessee shall assume all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whether by death, disease, injury, infection, or otherwise, and by any cause what so ever, and therefore agrees to hold stallion owner harmless for any and all damages associated therewith.
8. **IN THE CASE OF TRANSPORTED SEMEN:** I understand that the veterinarian that is to perform the insemination or the mare owner/lessee must contact the stallion owner **AND** collecting clinic by telephone, fax, or email confirming receipt, not more than 48 hours or less than 24 hours before semen will be shipped. Failure to do so may absolve stallion owner of any obligations under this contract. It is absolutely essential that communication be established and maintained directly between the insemination veterinarian and the collecting clinic. The success of the transported semen program depends upon the close cooperation between collecting clinic and the veterinarian managing the mare.
9. **TERMS:** The stallion owner must receive \$250 Non-Refundable booking fee with signed contract and the balance of the Breeding/stud fee, which can be paid ½ at time of first collection and the remainder of the balance due not later than 30 days after insemination providing the mare is confirmed safely in foal to: Gainey Cornerstone Arabians, PO Box 311 Amelia, VA 23002-0311
10. **TRANSPORTED SEMEN:** The mare owner/lessee is responsible for hauling (if necessary) and collection and shipping costs per shipment to include a deposit on equitainer of \$250 to be returned once equitainer is received (within 72 hours) from Mare owner. This fee is for the purpose of collection, the collection process, materials, and semen preparation for shipping
